LOCKING CONTROLS AND INTERCOMS
AT THE JUVENILE JUSTICE CENTER,
AND DELEGATING AUTHORITY TO THE
COUNTY ADMINISTRATOR TO EXECUTE
THE CONTRACT

WHEREAS, the detention locking controls at the Lane County Juvenile Justice Center, 2727 Martin Luther King, Jr. Blvd., Eugene, OR, are original to the year 2000 construction of that facility, obsolete, and have failed; and

WHEREAS, detention locking controls and intercoms are critical for providing safe and secure access and communications between detention spaces within the facility; and

WHEREAS, the project for replacing these controls is included in the approved Capital Improvement Plan and funding has been identified; and

WHEREAS, the Department Manager has reviewed and approved this project and its funding source;

NOW, THEREFORE, the Board of County Commissioners of Lane County **ORDERS** as follows:

1. The Juvenile Justice Center Locking Controls and Intercoms Project is approved for funding and construction.
2. The County Administrator is granted authority to execute all contracts relative to this project.
