TERM: This task force will complete a two phase analysis of the impacts of regional development scenarios on the commercial agricultural and forestland base in the Region 2050 area of central Lane County by June 30, 2006. A Lane County task force has no set term, it will disband upon completion of the assigned task.

COMMITTEE CHARGE: To provide a technical report to the Region 2050 Policy Board that identifies the commercial agricultural and forestland base in the region. This committee task force would review the relative impacts of three draft Alternative Regional Growth Scenarios on the region's commercial forestland and agricultural lands in May 2005. Once the Preferred Growth Scenario is developed by the Region 2050 Policy Board, the task force will review that scenario against the land base to determine if commercial resource lands are impacted by that scenario. This meeting will be held in April, 2006.

# D. BACKGROUND/ANALYSIS:

If, under the regional problem solving statute, there is a desire for implementation strategies that will affect the commercial farm and forest lands in the region, the participants (The Region 2050 Policy Board) shall consider the recommendation of this committee, which has expertise in appropriate fields, including farmers, foresters and representatives of the State Department of Agriculture, the State Department of Forestry and the Department of Land Conservation and Development. The regional problem solving statute addresses resource lands as currently defined in the statewide planning goals, and if there may be impacts to those lands through the implementation strategies, the participating County shall appoint this committee of experts to develop a report for the decision makers.

The Lane County Board of Commissioners reviewed the proposal to appoint this farm and forest lands committee, and determined the most appropriate category under Lane Manual 2.010 for the work to be completed is a task force. The reporting responsibility is to complete a resource lands report to be considered by the Region 2050 Policy Board in the event commercial resource lands are considered for uses not authorized under Statewide Planning Goals.

On January 3, 2005, staff was directed to develop an application process and committee charge, and advertise vacancies widely to the public and professions of farming and forestry for the Lane Manual prescribed minimum 30 days. There was interest in

increasing the private sector representation on the committee to add to the agency representation.

Five people that expressed an interest and agreed to participating in the Region 2050 Farm & Forest Committee did not submit an application in response to the vacancy announcement, therefore these names are not included in the appointment recommendation:

WHEREAS, The Board of Commissioners considered this item on January 3, 2005 and determined the nature of the committee to be appointed for the regional problem solving project is a task force, with a short term, specific task to identify lands in the region that are not part of the region's commercial agricultural or forestland base that could be considered by the Regional Problem Solving Program for uses not authorized by the statewide goals pursuant to ORS 197.656(6); and

  I have 12 years experience farming, running a small business (Full Circle Community Farm), and learning to understand the natural limits of land for food and tree production. We focus on local sales and a more localized economy. I am acutely aware of the interplay between the urban and the rural and the challenges this poses. I spent 10 years in home building and cabinetry I am aware of the power of listening and can help bring calmness and focus to a group. I have served on the boards of 3 non-profits since moving to Eugene in 1990, and have an understanding of the city's land use and development process as a development recently unfolded next to our home.

We live in a fairly transient society where people rarely know the place they want to buy, build, or develop. Without cohesive community, and a time-honored understanding of a place; without stewardship knowledge there is a lot of potential for poor land use decisions, for disparate interests to clash. Some day I hope planning efforts could be left primarily to families and neighbors. For now, it seems wise to lend a hand at a larger effort. In a 2050 presentation I saw I liked seeing more small communities being encouraged and I'd like to encourage a localized, holistic, sustainability approach to their creation.

Housing and development-high quality soil preservation-transportation-encouraging a concerned community-government flexibility.-a want by people to feel welcome and involved in a planning process. - 1. Experience: The attached biographical sketch summarizes my experience. I have been intimately involved in all aspects of planning over my nearly 40 years of professional life, most of it with the US Forest Service. As Forest Supervisor on the Shoshone National Forest in Wyoming and on the Boise National Forest in Idaho. I worked very closely with the county commissioners in both areas, particularly in joint planning efforts related to the national forests' financial contribution to the counties through the "25%" fund. As a leader of the Interior Columbia Basin Ecosystem Management Project (ICBEMP) which covered the interior portions of Oregon and Washington, all of Idaho and western Montana, I helped organize and work with the "Eastside Coalition of County Commissioners", 16 commissioners from the four states who, through the coalition, helped develop management strategies for the federal plans that would affect their counties.
- 2. Interest in the committee and contributions I would like to make: As I approach retirement, it's time for me to begin to "pay something back" to our carefully chosen home community for all the wonderful years and lovely places we have enjoyed throughout our career, mostly in the Inland West. I know planning well, and that's where my contribution might be the best, and most useful to others. I bring a broad and deep knowledge of federal and state natural resource management and regulatory policy and processes related especially to forestry, wildlife, water quality and Endangered Species Act (ESA) issues. I believe in good teamwork, and as a member of the Lane County Planning Team I would hope to add value by helping connect, where appropriate, issues and opportunities to their broader federal and state contexts. This could add to the quality of planning efforts and provide financial rewards through new conservation partnerships. Opportunities are apparent in current and potential activities of the Lane Council of Governments and in other ongoing partnership projects such as the Coastal Landscape Analysis and Modeling Study (CLAMS) where OSU and US Forest Service researchers are assessing ecological and socio-economic effects of alternative management policies on multiple ownerships in the Oregon coast range.
- 3. Community concerns to be addressed: I am most concerned about renewal of the Secure Rural Schools & Community Self-Determination Act for county funding after 2006. Effective county planning and programs depend on its continued full funding. Contingencies of partial or discontinued funding must be considered and options

- developed. One option would be revision of the Northwest Forest Plan-clearly justified on an ecological basis-which could provide significant revenues from forest restoration and thinning projects.
- 4. Involvement in community groups: Please see #1 above. As Idaho Fish and Game Director, I used community advisory groups widely. In the many different US Forest positions I held, I worked on/with many such advisory groups to develop cooperative approaches to effective public policy. I can provide many detailed examples if needed.
