#### 1. Proposed Motion:

MOVE TO ACCEPT BID LCP 2005-01 FOR A CONSTRUCTION CONTRACT FOR LANE COUNTY BUS BARN ROOF REPLACEMENT IN THE AMOUNT OF \$71,400.

#### 2. Issue/Problem:

The Bus Barn facility which is owned by the County and leased to Oak Street Development Center and other tenants has had roof failures over the past two winters. In order to protect the asset an allocation was placed in the FY05 CIP/Budget for repairs.

#### 3. Discussion:

### 3.1 Background

Bid documents were prepared with a bid opening of May 19, 2005. Legal Notices for the construction contract for the project were prepared and advertised in the <u>Register-Guard</u> and the <u>Daily Journal of Commerce</u> on April 15, 2005. In response to the Invitation for Bid, two bids were received, as listed on the Bid Opening Recap Sheet. All bidders provided the First Tier Subcontractor Disclosure Forms.

## 3.2 Analysis

All bids were evaluated by Management Services, and by Berry Architects, for conformance to bid specifications and requirements. The bid submitted by Umpqua Roofers was determined to best meet the bid specifications and had

the lowest price. Alternate #1 for new skylights was not accepted due to budget constraints.

#### 3.3 Alternatives/Options

- a. Accept the base bid from Umpqua Roofers and award contract.
- b. Reject bids

#### 3.4 Recommendation

It is recommended that award of bid LCP 2005-01 be made to the low responsive bidder, Umpqua Roofers based on conformance to bid specifications and the lowest price; a contract and change order to be signed by the vendor; and the County Administrator be authorized to execute the contract and change order.

#### 4. Implementation/Follow-Up

Following approval of the bid award , a contract and change order will be signed by the vendor and delivered to the County Administrator for execution. A pre-construction meeting with the contractor will also be initiated.
