Α. Background / Analysis

Mental retardation and other developmental disabilities affect more than 7 million Americans and their families. In Lane County four thousand people with developmental disabilities live, work and recreate in our communities. The Lane County office of Developmental Disabilities Services is working together with a group of local agencies to raise public awareness about developmental disabilities and to increase local efforts toward enabling people with developmental disabilities to live full and productive lives of inclusion in our communities.

Events planned include a diversity fair at the Gateway Mall on March 12, 2005 and a series of presentations about developmental disabilities in local elementary schools. In addition, local employers will be recognized for their efforts in employing people with developmental disabilities and an exhibit will be on display all month at the Gateway mall showcasing local agencies.

- 2. Not to recognize and support National Developmental Disabilities Month in Lane County.
