AGENDA ITEM TITLE: IN THE MATTER OF THE ALTERATION OF A PORTION OF DELTA

HIGHWAY (COUNTY ROAD NO. 1354) LOCATED IN SECTIONS 18 AND 19, TOWNSHIP 17 SOUTH, RANGE 3 WEST OF THE WILLAMETTE MERIDIAN.

I. MOTION

In the Matter of the Alteration of a Portion of Delta Highway (County Road No. 1354) located in sections 18 and 19, Township 17 South, Range 3 West of the Willamette Meridian.

II. ISSUE

To decide whether to approve the Order of Alteration that would accept a dedication of county-owned road fund land for public road purposes and also vacate the excess right of way.

III. DISCUSSION

A. Background

Delta Highway was established as County Road Number 1354 in 1968 with a variable right of way width. The portion of road proposed to be altered is located within the City of Eugene between Belt Line Road and Valley River Drive. The City of Eugene has proposed a water resource project involving the Delta Ponds area of Eugene in partnership with the U.S. Army Corps of Engineers. Lane County is working with the City of Eugene in their endeavor to enhance the wetland and riparian resources in the Delta Ponds area. Portions of the lands needed for the project are currently in Lane County ownership and are either excess right of way, or excess County-owned road fund land. An alteration of Delta Highway will establish what property is needed for right of way and clarify what lands can be relinquished to the City for the Delta Ponds project.

The Board of Commissioners approved Resolution and Order No. 04-2-18-4 directing Public Works staff to assist the City of Eugene with the Delta Ponds Restoration Project by providing necessary surveying and engineering needed to prepare the legal descriptions to submit the transfer and/or vacation proceedings for consideration of the Board.

B. Analysis

Altering Delta Highway will provide for the dedication and acceptance of portions of the County-owned road fund property as public right of way, for use as right of way now or retained for future improvements of Delta Highway. The alteration will also vacate certain areas that are not needed for use as right of way, with the intent to transfer the excess right of way, as well as excess

County-owned road fund property to the City of Eugene in connection with the Delta Ponds Restoration project.

The report by the Director of the Department of Public Works, attached to the Order as Exhibit "B", notes that no new construction of the Highway is planned at this time, but the alteration of Delta Highway is in anticipation for future transportation needs of the citizens of Lane County. The Order of Alteration provides for the dedication and acceptance of county-owned property. The centerline description of the new alignment, including right of way widths, is attached to the Order as Exhibit "A."

C. Alternatives/Options

The Board of County Commissioners has the options to:

- 1. Approve the Order of Alteration of a portion of Delta Highway (County Road No. 1354).
- 2. Have staff review and alter any component of the Order of Alteration.
- 3. Continue the motion for further consideration

D. Recommendations

It is recommended that the Board of Commissioners approve Option 1. This will approve the Order of Alteration of a portion of Delta Highway as proposed and supported by the Public Works Director.

E. Timing

Timing is important, as the Alteration of Delta Highway will allow portions of county-owned land in this area to be relinquished to the City of Eugene for the Delta Ponds Project.

IV. IMPLEMENTATION/FOLLOW-UP

Upon approval by the Board of County Commissioners, the Order of Alteration and related attachments will be forwarded to the County Clerk for filing and entering into the Board of Commissioners' Journal of Administration. The Order of Alteration will be filed and indexed into the Road Index Books and legal County Road Files administered by the Department of Public Works and the County Surveyor.

The Board of Commissioners approved Resolution and Order No. 04-2-18-4 directing Public Works staff to assist the City of Eugene with the Delta Ponds Restoration Project by providing necessary surveying and engineering needed to prepare the legal descriptions to submit the transfer and/or vacation proceedings for consideration of the Board. The surveying and engineering of the new alignment has been completed. An Order to legally alter Delta Highway has been prepared. The Order of Alteration provides for acceptance of a deed, marked as Exhibit "C", dedicating three parcels of county-owned road fund land for public road easement. The legal description of the new alignment, including right of way widths, is marked Exhibit "A" and attached to the Order.

No new construction of Delta Highway is planned at this time. The alteration of Delta Highway is in anticipation for the future transportation needs of the citizens of Lane County.

Upon approval, the Order will be filed with the Lane County Clerk and entered in the Board of Commissioners Journal of Administration. The Order will also be filed and indexed into the Road Index Books and legal County Road Files administered by the Department of Public Works and the County Surveyor.


