(DORENA) COVERED BRIDGE AT M.P. 0.06

### 1. MOTION

THAT THE ORDER BE APPROVED IMPOSING A TEMPORARY WEIGHT RESTRICTION (3 TONS) FOR THE SHOREVIEW DRIVE WAYSIDE (DORENA) COVERED BRIDGE AT M.P. 0.066.

### II. ISSUE OR PROBLEM

Recent inspections have revealed structural deterioration and damage warranting a temporary weight restriction for this bridge.

## III. DISCUSSION

### A. Background

An inspection of the Dorena Covered Bridge located at the Shoreview Drive Wayside at M. P. 0.066, that was performed by CH2M Hill has revealed defects in the load-carrying members of the bridge due to insect attack and/or rot. The deterioration was found in the top chord of the right truss.

# B. Analysis

Lane Code 15.215 provides that the Director of the Department of Public Works is delegated authority by the Board to impose temporary weight restrictions on roads and bridges under emergency conditions, and may post bridges or roads with such weight restrictions in the event of threat to public safety or extensive damage to public roads or bridges. The code language requires that the action be abated unless confirmed at the next public meeting of the Board with a duly executed Board Order.

Based on analysis of the CH2M Hill report, the Director of Public Works has determined that the deterioration constitutes an emergency situation, and in accordance with the recommendations of the consultant, has ordered that the bridge be posted for a weight limit of 3 tons and has curtailed the issuance of Facility Permits allowing any public or private assemblies on the bridge until the necessary repairs can be made. Signing reflecting the reduced weight limit was installed on February 28, 2005.

Because this bridge is located in the Shoreview Drive Wayside, and because the bridge is mainly used by pedestrians, passenger cars and unloaded pickups, the weight restriction should not pose any significant hardship for the users of the Wayside. The bridge connects a driveway approach off of Shoreview Drive with a small parking lot on the opposite side of Row River. The bridge has been used in the past by Permit for gatherings such as weddings, and once the repairs have been made, they will again be allowed subject to issuance of a Special Event Facility Permit.

The cost of the needed repairs has been estimated at \$100,000. This amount will be included in the recommended 2006/2010 Capital Improvement Program (CIP), currently being reviewed by the Roads Advisory Committee. It is anticipated that the repairs can be completed during the upcoming construction season.

## C. Alternatives/Options

- 1. Approve the Order confirming the action of the Director of the Department of Public Works in imposing the temporary weight restriction for Shoreview Drive Wayside (Dorena) Covered Bridge at M.P. 0.066.
- 2. Decline to approve the Order and direct staff otherwise.

## D. Recommendations

Alternative No. 1 is recommended.

# E. Timing

The temporary weight restriction will become effective as of the date the Order is approved.

### IV. IMPLEMENTATION/FOLLOW-UP

Staff will notify local news media of the revised posting.


