## I. MOTION

ORDER/IN THE MATTER OF RE-CERTIFYING THE LANE WORKFORCE PARTNERSHIP BOARD OF DIRECTORS AS THE LOCAL WORKFORCE INVESTMENT BOARD UNDER THE WORKFORCE INVESTMENT ACT OF 1998

### II. AGENDA ITEM SUMMARY

In July 2000, the Lane County Board of Commissioners designated the Lane Workforce Partnership as the local workforce investment board under the Workforce Investment Act. The U.S. Department of Labor requires re-certification of this designation every two years.

The Board of County Commissioners last recertified the Lane Workforce Partnership board of directors as the local workforce investment board on April 5, 2006 for the period July 1, 2006 and ending June 30, 2008.

The board is being asked to give the Lane Workforce Partnership authorization to request re-certification by the Governor as the local Workforce Investment Act board for the period July 1, 2008 through June 30, 2010.

## III. BACKGROUND/IMPLICATIONS OF ACTION

## A. Background

As stated in the Workforce Investment Act of 1998 [Section 117(c)(2)] and Oregon Administrative Rule (OAR) 151-010-0060, the Governor shall certify a local board every two years with the initial certification period beginning July 1, 2000. In January 25, 2000 the Board of County Commissioners designated the Lane Workforce Partnership board of directors as the local workforce investment board under the Workforce Investment Act of 1998. Subsequently, the Governor certified the Lane Workforce Partnership board of directors as the local Workforce Investment board.

It is time to reapply to the Governor to re-certify the Lane Workforce Partnership as the local workforce investment board. The Board of Commissioners is being asked to give the Lane

Workforce Partnership authorization to request re-certification by the Governor as the local Workforce Investment Act board for the period July 1, 2008 through June 30, 2010.

### B. Policy Issues

As stated in the Workforce Investment Act of 1998 [Section 117(c)(2)] and Oregon Administrative Rule (OAR) 151-010-0060, the Governor shall certify a local board every two years with the initial certification period beginning July 1, 2000. In January 25, 2000 the Board of County Commissioners designated the Lane Workforce Partnership board of directors as the local workforce investment board under the Workforce Investment Act of 1998. Subsequently, the Governor certified the Lane Workforce Partnership Board of Directors as the local Workforce Investment Board.

The Board of County Commissioners last recertified the Lane Workforce Partnership board of directors as the local workforce investment board on April 5, 2006 for the period July 1, 2006 through June 30, 2008.

In order to receive Workforce Investment Act appropriations and to remain in compliance with federal and state regulations, the Lane Workforce Partnership board of directors must be recertified as the local Workforce Investment Board. Therefore, the Workforce Partnership board of directors requests authorization to request re-certification as the local Workforce Investment Board for Lane County for the period July 1, 2008 through June 30, 2010.

### C. Board Goals

The Lane Workforce Partnership is committed to strengthening Lane County's competitiveness in a global economy by preparing the current and future workforce to meet the skill needs of employers. To accomplish this, the Lane Workforce Partnership board of directors developed a system of services with four categories of customers in mind: businesses, the universal job seeker, the lowincome adult, and the dislocated worker. All of these customers are served through the Workforce Partnership's comprehensive service delivery center, The Workforce Network and, through a contract with Lane Community College. All but the business customer are served at The Workforce Network satellite on the college campus.

As the local Workforce Investment Board that provides services to businesses and Lane County citizens, the Workforce Partnership addresses the following Board of County Commissioners' goal: Work for a strong regional economy to expand the number of family wage jobs available in Lane County. This goal is advanced through targeting of resources to growing industry clusters in Lane County, as well as through occupational skill training of current and emerging workers.

### D. Financial and/or Resource Considerations

As the designated Workforce Investment Board, the Lane Workforce Partnership is eligible to receive Workforce Investment Act funding to provide services to Lane County citizens and businesses. To not approve application for re-certification of the Lane Workforce Partnership board of directors as the local Workforce Investment Board under the Workforce Investment Act of 1998 would result in loss of federal job training funds to serve businesses, youth, adults and dislocated workers in Lane County.

#### B. Analysis

Per the Workforce Investment Act of 1998 [Section 117(c)(2)] and Oregon Administrative Rule (OAR) 151-010-0060, the Governor shall certify a local workforce investment board every two

years. In order to receive federal job training funds to provide services to businesses, the universal job seeker, the low-income adult, and the dislocated worker, the Lane Workforce Partnership board must be recertified as the local Workforce Investment Board.

To complete the re-certification process, a "Local Workforce Investment Board Re-certification Request" form must be completed and signed by the Chair, Lane County Board of County Commissioners.

## C. Alternatives/Options

To not approve re-certifying the Lane Workforce Partnership board of directors as the local Workforce Investment Board under the Workforce Investment Act of 1998 would result in loss of federal job training funds to serve businesses, youth, adults and dislocated workers in Lane County.

## D. Recommendations

To re-certify the Lane Workforce Partnership board of directors as the local Workforce Investment Board under the Workforce Investment Act of 1998 for a two year period beginning July 1, 2008 through June 30, 2010.

## E. Timing

Upon Board of County Commissioners' approval, the Lane Workforce Partnership will submit the "Local Workforce Investment Board Re-certification Request" form to the State Office of Community Colleges and Workforce Development who will in turn submit the re-certification request to the Governor for approval.

#### IV. IMPLEMENTATION

Re-certification becomes effective July 1, 2008 through June 30, 2010 upon approval of the Governor of Oregon.
