BOARD ADVISORY COMMITTEE

I. PROPOSED MOTION:

That the Board of County Commissioners appoint four members to the Farm Review Board Advisory Committee, per recommendations on the attached Citizen Advisory Committee Appointment form for two-year terms ending April 14, 2010.

II. ISSUE OR PROBLEM:

The Farm Review Board will meet on April 21, 2008 and current vacant positions need to be filled prior to the scheduled meeting.

III. DISCUSSION:

A. BACKGROUND:

The Farm Review Board advises the County Assessor with respect to the income approach factors being utilized by the Assessor in arriving at the values for farm use farmland. The Farm Review Board reviews these submitted income approach factors and shall advise the County Assessor as to whether the factors being so utilized are proper under ORS 308A.092.

B. ANALYSIS:

Bart Edwards is a returning member of the Review Board, sits on rural boards and commissions and is an active crop farmer. Duane Hofer is a returning member of the Review Board who has served on the committee for 17 years and has been farming in Lane County for 40 years. Randall Hledik has participated on the committee for 17 years serving as the fifth board member appointed by the board and recently as a board member appointed by the Board of County Commissioners. He manages several hundred acres of land for a sand and gravel company, much of which is leased for farming. Charles Stolsig has served on this committee for 27 years. He sits on other rural boards and commissions, and owns and operates his own farm and manages property that is leased out for farming.

The openings were advertised for thirty days and we received four applications. Mr. Stolsig, Mr. Edwards, Mr. Hofer and Mr. Hledik are quite knowledgeable about the subject matter and their continued contribution would be valuable to us.

C. ALTERNATIVES/OPTIONS:

Re-open the process and advertise the openings again.

D. RECOMMENDATION:

The Board of County Commissioners appoints two members and the Assessor appoints two members per the attached Citizen Advisory Committee Appointment Sheet.
