WHEREAS, in the past the Lane County Human Rights Advisory Committee provided funding each year to help defray the cost of the Springfield MLK Jr. Celebration; and

WHEREAS, the Martin Luther King, Jr. Celebration Committee is now planning the 2009 celebration and has asked the Lane County Board of Commissioners for financial support; and

WHEREAS, it now appears to the Board of Commissioners that a transfer of \$500 from the Operational Contingency to Materials and Services within the General Fund is necessary to provide sufficient funds to help support the 2009 MLK Jr. Celebration; and

WHEREAS, the Board of Commissioner, as per ORS 294.450(1), has authority to transfer appropriations within a fund if appropriations are moved from one organizational unit or appropriation to another; and

WHEREAS, the need, the purpose and the amount of the transfer are herein described;

NOW, THEREFORE, IT IS HEREBY ORDERED that \$500 be transferred from the General Fund Operational Contingency to the Materials and Services appropriation within General Expense to help support the 2009 Martin Luther King Jr. Celebration.
