REQUIRED AGREEMENT DOCUMENTS

#### 1. MOTION

Move to give approval to the Department of Youth Services to apply for Federal Financial Assistance Applications for Title II funds for FY 10-11, and to authorize the County Administrator to sign the required applications.

#### II. ISSUE OR PROBLEM

The Forest Service and Bureau of Land Management have certain procedural steps for the disbursement of Title II funds. It starts with an initial application and presentation to Resource Advisory Committees (RAC)s. Following project approval RACs, Lane County must submit an Application for Federal Assistance. An authorized representative must sign these applications. The Department of Youth Services has received project approval from:

- Eugene BLM for \$143,750 (\$120,750 for Youth Services operations and \$23,000 for BLM project costs.)
- Roque-Umpqua National Forest for \$20,000
- Willamette National Forest for \$84,500

Youth Services now needs to submit the Applications for Federal Assistance and have those applications signed by the County Administrator so that the funds can be utilized for Juvenile Forest Work Team projects.

#### 111. DISCUSSION

#### A. Background/Analysis

Title II funds are being used to fund the Department of Youth Services Juvenile

Forest Work Crew operations. This partnership began in 2001 and continues to be of mutual benefit to the National Forests, community, and youth and families that are served at Youth Services. These projects utilize the labor of juvenile offenders while simultaneously training them to acquire valuable job skills. The work performed enhances public lands, improves habitat and reduces risk of wildfires. Juvenile workers are paid to be on crews and have the ability to pay restitution to the victims of their crimes.

Lane County requested funds from three RACs within Lane County for Title II funds and those requests have been approved. The Federal Assistance Application is a procedural step required before Lane County can receive payments. The Board has granted approval for the prior years FY03-FY10 under Board Orders 04-3-31-6, 05-3-16-6, 06-3-15-11, 07-5-23-10, 08-5-14-14, and 10-6-16-6.

# B. <u>Alternatives/Options</u>

- Make approval for Youth Services to complete applications for Title II
  funds and authorize the County Administrator to sign the resulting
  documents in order to continue to operate the juvenile work crews as
  planned.
- Do not make approval for Youth Services to apply for Title II funds and close the juvenile work crew program.

## C. Recommendation

To approve #1 above and move to adopt the order.

### IV. IMPLEMENTATION

Upon Board action, the Lane County Department of Youth Services will apply for the Title II funds. If awards are received, they will be signed by the County Administrator and the programs continued.

## Management Solutions Proposal for Services to Lane County Government

## February 7, 2011

Lane County has asked Management Solutions to submit a letter proposal for consulting services. The purpose of the work is to investigate the timing and methodology to enhance decision-making/goal-setting by the Board of County Commissioners. Management Solutions is pleased to offer this proposal.

### Methodology

Stan Biles will personally conduct all work on this project. Using one-on-one interviews of Commissioners, other county elected officials and appropriate staff I will evaluate the state of current relationships. I will assess the likelihood of successful goal-setting work in the short, medium, and long terms. I will seek out sources of tension and determine the basis for any tension and the level of tension.

I will determine whether a goal-setting session in the short-term has an acceptable probability of success. If so, I will propose a goal-setting methodology for the county's consideration.

#### Schedule

This work can be completed before March 7 if I can gain access to all participants during the next three weeks. I can begin interviews this week, as early as schedules allow.

### Cost

I will bill at the rate of \$195.00/ hour. Mileage will be billed at .50/mile. Meals will be reimbursed at whatever per diem is used by county employees. Total cost will not exceed \$5,000.00 without advance written approval by Liane Richardson.

#### **Final Deliverable**

I will present my findings and recommendations to Liane Richardson in an oral report.
