Dear Administrator Richardson:

As the Association of Oregon Counties' representatives on the National Association of Counties (NACo) Board of Directors, we are very enthusiastic about the NACo annual conference coming to Multnomah County July 15-19, 2011. This is a great opportunity to highlight Oregon and all of its counties. When Oregon hosted the 1998 NACo conference a record number of attendees came early, stayed late and made a sizable contribution to Oregon's economy.

Multnomah County, as the host, has shouldered the responsibility to raise the funds necessary to hold this conference. Even with several cost-saving innovations (such as the use of mass transit instead of private bus service between hotels and the convention center) the host's commitment is \$600,000. Multnomah County, under the admirable leadership of Commissioner Diane McKeel, is actively seeking corporate sponsorships. However, there is still a ways to go to reach the financial goal.

We seek assistance from all Oregon counties to help Multnomah County sponsor this event. AOC's goal is for each county to become a supporter through a joint Oregon counties sponsorship. This proposal was introduced to the membership at the 2010 AOC annual conference; the specifics of the plan are attached. Two counties – Umatilla and Benton – have already committed to contribute \$2,000 to the Oregon Counties fund. Additionally, Umatilla County has committed to contribute an additional \$10,000 as a direct conference sponsor.

We know county budgets are extremely tight but hope you and your board will consider a meaningful contribution to the Oregon counties sponsorship fund. You may want to consider using some of your video lottery revenue, which is dedicated to economic development.

Thank you for your consideration; we will be following up with a phone call to answer any questions you might have. We hope you plan to attend the NACo conference July 15-19 in Multnomah County.

Goal: Oregon's counties individually and through AOC become an event sponsor.

How: County boards commit to participate at one of three levels:

Pine \$500-\$999Fir \$1,000-\$1,999

Cedar \$2,000 +

Board: AOC commits Business Partner revenue of \$5,000 (Base sponsor level).

Fund: AOC aggregates contributions and selects which event it wishes to sponsor. Possible

options for sponsorship include being a co-sponsor of the conference-wide event or

sponsoring a general session or speaker.

Rationale: This conference is good for Oregon's economy. Many attendees will come early, stay late

and travel around the state spending money. Oregon attendees will save on travel to the

annual conference, so the contribution could come from county travel budgets.

History: Oregon last hosted a NACo annual conference in 1998. Clackamas, Marion, Multnomah

and Washington counties co-sponsored the 1998 conference. The remaining 32 Oregon counties all made financial contributions of varying amounts, giving the co-sponsors

bragging rights to call NACo '98 an "All Oregon Event."

Many NACo members still speak glowingly of their wonderful memories of that Oregon

conference and look forward to another visit to our state. A NACo attendance record for

annual conferences was set at the '98 event.
