I. MOTION

TO APPROVE THE ORDER IN THE MATTER OF AMENDING CHAPTER 64 OF THE LANE MANUAL TO COMBINE CENTRAL AND UPPER WILLAMETTE JUSTICE DISTRICTS (LM 64.205), AND THE ORDER CLOSING THE OAKRIDGE JUSTICE COURT.

II. AGENDA ITEM SUMMARY

The Lane County Board of County Commissioners is being asked to approve the combining of the Central Lane Justice District and Upper Willamette Justice District to form one justice district titled the Central and Eastern Lane Justice District, and close the Oakridge Justice Court.

III. BACKGROUND/IMPLICATIONS OF ACTION

A. <u>Board Action and Other History</u> At its August 8, 2010 meeting, the Board of Commissioners discussed the combining of the Upper Willamette Justice District with the Central Lane Justice District to cover the territory currently served by both districts. Combing the districts would also allow the justice court in Oakridge to be closed. The Board was in favor of the change, in large part, because it would result in a savings of approximately \$50,000. In addition, improved efficiencies might result in better service to those within the revised district.

The proposed Orders would combine two of the three justice of the peace districts, leaving two districts, and close the justice court currently associated with the Upper Willamette Justice District in Oakridge.

- **B.** <u>Policy Issues</u> This proposal involves the issue of whether the costs saving of eliminating one of three justice of the peace districts is warranted.
- **C.** <u>Board Goals</u> This proposal furthers the goal and core strategy of providing governmental services efficiently.
- **D.** <u>Financial and/or Resource Considerations</u> Staff anticipates that combing these two justice of the peace districts would result in a savings of approximately \$50,000.
- E. <u>Analysis</u> ORS 51.020(1) provides: "The ... board of county commissioners of every county may set off and establish, or modify the boundaries of, justice of the peace districts within the county." Inherent within this authorization is the authority to eliminate a previously created district and to modify another district to encompass the territory previously served by the eliminated district. Accordingly, the Board has the authority to eliminate the Central Lane Justice District and modify the boundaries of the Upper Willamette Justice District as proposed. The Upper Willamette Justice District would be renamed as the Central and Eastern Lane Justice District, and its territory would include all of Lane County other than the territory within the Florence Justice District and the territory within the corporate boundaries of the City of Eugene. The court for the Central and Eastern Lane Justice District would be located in Springfield and the court in Oakridge would be closed.

F. Alternatives/Options

- Approve the change to Lane Manual chapter 64 and the closing of the Oakridge Justice Court as proposed.
- 2) Reject the proposed change to Lane Manual chapter 64, preserving the current boundaries of the three justice of the peace districts, and maintaining the Oakridge Justice Court.

Approval of the amendment to Lane Manual chapter 64 takes effect upon Board adoption of the order. Termination of the lease for the space occupied by the Oakridge Justice Court would accomplished by staff according to Board order. No follow up is needed unless the Board prefers an alternative to that set forth here.

WHEREAS, the Central Lane Justice of the Peace position has been vacant since the retirement of Justice Sinclair in 2010: and

WHEREAS, the Board of Commissioners have explored many options in regards to the makeup of the Justice Courts in Lane County in order to continue to provide service to Lane County residents while also ensuring that the courts are fiscally sound; and

WHEREAS, the Board of Commissioners have heard several recommendations and have been provided with public and staff input over the last six months, and

WHEREAS, the Board of County Commissioners of Lane County is aware that the Upper Willamette Justice District court and the Florence Justice District court are both underutilized such that the benefits of the courts to Lane County citizens are outweighed by the administrative costs of operation; and

WHEREAS, the Board of County Commissioners is mindful of the importance of reducing County administrative costs wherever possible, and has determined that it is in the best interest of a majority of the citizens of Lane County to consolidate the Upper Willamette Justice District court with the Central Lane Justice District court and to handle all criminal matters regularly cited into the three justice courts in Central Lane Justice District court in order to streamline the processes.

NOW, THEREFORE, IT IS HEREBY ORDERED that Justice of the Peace position for the Central Lane Justice District be eliminated, and

IT IS FURTHER ORDERED that the Upper Willamette Justice District be consolidated with the Central Lane Justice District, and that the new combined District be named the Central and Eastern Lane County Justice District.

IT IS FURTHER ORDERED that the operations at the Upper Willamette Justice Court located in Oakridge, Oregon be closed and all court operations cease, effective as of the close of business on June 30, 2011.

IT IS FURTHER ORDERED that the Florence Justice Court District court will remain open in order to handle civil matters arising in the Florence area.

IT IS FURTHER ORDERED that the County Administrator is authorized to take all reasonable steps to implement this order including modifying or terminating the term of the lease of the Willamette Activity Center in Oakridge, Oregon.

Chapter 64 - JUSTICE COURTS

64.200 Authority for Justice of the Peace Districts of Lane County.

The Justice Courts are a part of the state court system and operate pursuant to Oregon State statutes, ORS Chapters 51 and 55. (Revised by Order 99-9-1-2; Effective 9.1.99)

64.205 District Voting Boundaries.

There are three Justice of the Peace Districts within Lane County: the Florence Justice District and the Central and Eastern Lane Justice District. The Florence Justice District is, located in western Lane County and includes the City of Florence and the precincts of Florence, Glenada, Heceta, Mapleton, Mercer and Swisshome. The Central and Eastern Lane Justice District covers the remaining central and eastern areas of Lane County, including the Cities of Springfield and Oakridge, and the precincts of Oakridge 1, Oakridge 2, Salmon Creek and Westfir, but excludes any territory within the City of Eugene. The district boundaries are determined according to the descriptions included in Appendix "A" to this section and outlined by the accompanying map included in Appendix "B" to this section. Questions regarding whether specific territory is included in either district may be directed to the Management Services (County Clerk division) of Lane County, Oregon. (Revised by Order 99-9-1-2, Effective 9.1.99; 03-1-15-5, 1.15.03)

64.210 Criminal Jurisdiction.

Criminal jurisdiction extends to all misdemeanors or as otherwise defined by state law. (Revised by Order 99-9-1-2; Effective 9.1.99)

64.215 Civil Jurisdiction.

Civil jurisdiction extends generally to those cases where the amount of money, damages or specific property claimed does not exceed \$5,000and which are not excluded by state law. (Revised by Order 99-9-1-2; Effective 9.1.99; 03-1-15-5, 1.15.03)

64,220 Small Claims.

The Small Claims Department has jurisdiction for the recovery of money or damages where the amount claimed does not exceed \$5,000 and has sole jurisdiction where the amount claimed does not exceed \$200. (Revised by Order 99-9-1-2; Effective 9.1.99; 03-1-15-5, 1.15.03)

Beginning at the intersection of the North Boundary of Lane County and the top of the ridge separating the drainage basin of Lobster Creek and its tributaries from the drainage basins of Lake Creek and Swamp Creek and their tributaries in Section 7, Township 15, Range 7 West, Willamette Meridian; thence Southerly along said ridge and the ridge dividing Deadwood Creek and its tributaries from Greenleaf Creek; then the ridge dividing Wheeler Creek and Chapel Creek drainage basins, downstream Chapel Creek to Lake Creek, thence downstream Lake Creek to the point of intersection of the center of the main channel of Lake Creek and the centerline of the Lane County Garbage Dump Road in Section 14, Township 17 South, Range 9 West; Willamette Meridian; thence Southerly along said road to the Garbage Dump to the ridge dividing the tributaries of

This Justice District includes the Precincts of Florence, Glenada, Heceta, Mapleton, Mercer and Swisshome.


CENTRAL AND EASTERN LANE JUSTICE DISTRICT


