#### I. MOTION:

IT IS MOVED THAT AUTOMATIC HEAT SERVICE AND INSTALLATION BE AWARDED CONTRACT #11-C-0027 FOR THE VILLAGE OAKS DUCTLESS HEAT PUMPS AND BATH FANS AND THAT AN ORDER TO THIS EFFECT BE SIGNED; AND AN AGREEMENT BE EXECUTED IN ACCORDANCE WITH BID DOCUMENTS.

#### II. ISSUE

Board approval is required to award a contract for the Village Oaks Ductless Heat Pumps and Bath Fans, located in Eugene, Oregon.

#### III. DISCUSSION

#### A. Background:

Project Addresses: 3602-3620 West 18<sup>th</sup> Avenue Eugene, Oregon Village Oaks Apartments, a sixty-seven unit, low-rent, multi-family apartment complex, is located at 3602-3620 West 18<sup>th</sup> Avenue, Eugene, Oregon. The complex is comprised of seven (7) two-story and three (3) one-story buildings.

The sixty-seven apartments are currently heated by a mixed combination of electric ceiling heat and wall mounted space heaters. This contract replaces the living space heating systems with electric Energy Starcertified ductless heat pumps (DHP).

In addition to installing sixty-seven ductless heat pumps, the contract includes replacing all existing, original bath exhaust fans with high efficiency, Energy Star-certified bath fans and associated work.

Funding for the ductless heat pumps (DHP) and the bath exhaust fans is being provided through a community partnership between EWEB and the US Department of Energy American Recovery and Reinvestment Act (ARRA). Because of the heating efficiency of the DHP, the estimated annual savings is \$170.00 to \$200.00 for each resident. Over the lifetime of the system, the annual savings to investment ratio (adjusted for fuel cost escalation) is estimated at 1.3.

#### B. Analysis

A formal bid process with a bid package was issued by the Agency for the required work. Four bids were obtained, and the lowest bidder is responsive and responsible and they have reviewed their bid and confirmed their costs.

#### C. Alternatives/Options

In that the public bidding process was employed, the lowest bid has no irregularities and is responsive and responsible, the prices are considered competitive, and there are sufficient budget funds to cover the project, we recommend award of the contract to Automatic Heat Service and Installation.

Automatic Heat Service and Installation will provide a 100% Performance Bond and a 100% Payment Bond for this contract.

#### D. Recommendation

Approval of the proposed Motion.

### E. <u>Timing</u>

Upon bid award, the contractor shall have ten days to provide the Agency with a signed contract. It is anticipated that all other necessary documents could be processed by March 25, 2011 and work would commence shortly thereafter.
