
## JURISDICTIONS, LAND USE, and ZONING in LANE COUNTY

## LANE COUNTY HAS LAND USE REGULATORY JURISDICTION OVER:

1. Areas outside the urban growth boundary (UGB) of any city or town within the county. The zoning regulations can be found in the Lane Code Chapter 16, once zoning has been determined;



- 2. Areas outside the city limits, but within the urban growth boundary of any incorporated community, except the cities of Eugene and Springfield (see below). The zoning regulation can be found in the Lane Code Chapter 10, once zoning has been determined; and
- 3. Any unincorporated community within the county (see below). Zoning regulations can be found in the Lane Code Chapter 16, once zoning has been determined.

You will be asked to provide either a map and tax lot number or a site address, so please be sure to have this information.

Areas within the city limits of any incorporated city **OR** within the urban growth boundary of the cities of Eugene or Springfield.
