- Bites Code required report of a bite resulting in skin breakage. Some may include a dispatch call for a Dangerous Behavior complaint.
- DB New Dangerous Behavior, new formal complaints processed/citation issued
- Voucher Approved and processed, not necessarily used
- **Voucher** Used, submitted for payment to LCAS (from Vet)
- Impounds Includes DOA's (dead on arrival)
- PR Public relations. An informal request for contact to 'talk' to a citizen about an issue. Complainant doesn't want a ticket issued.
