#### 00:13:09 New Business

- Water & Sewer Infrastructure Feasibility Study RFP ARPA
- Ponderosa Project Habitat stewardship project now underway at Howard Buford Park. The Friends of Buford Parks Mt. Pisgah received a grant from the Oregon Watershed Enhancement Board and they are managing the project with oversight from Parks' Natural Areas Coordinator, Ed Alverson. The project proposal the Friends of Buford Park submitted is included in the meeting materials. Alverson presented an aerial photo of the project area in the North East corner of the park. The project is primarily a savanna restorations project with the goal of thinning the trees, reducing tree density so areas that are now forest and woodland will end up being much more open. Another goal is to reduce invasive species through seeding of native plants from the native plant nursery to increase the abundance of the native oak savanna. Shanley inquired about follow up on these types of projects. Alverson stated this effort is better funded than in the past in terms of providing follow-up treatments necessary after a burn. Shanley stated Parks should have a plan to go back in to sustainably manage the Savanna. Alverson stated lack drought conditions affecting mowing and lack of staff have been issues. Shanley stated the long-term stewardship needs to be a necessary part of the five-year review of the Habitat Management Plan.

## **Ponderosa Project activities include:**

- 1. Coordination, contracting, and permitting logging activities
- Marking trees for removal and retention; delineation of logging units; preparation of forwarder and/or skid trails, log decks, and landings; removal of conifer and hardwood trees as prescribed on a unit by unit basis; and processing merchantable materials namely logs and slash for export)
- 3. Marketing, sale, and delivery of merchantable logs and other products to area businesses (namely local mills)
- 4. Management of project related traffic along trails and at the trail head
- 5. Management of recreational traffic (equestrians and hikers) passing through the project area including periods of limited trail closure
- 6. Management of invasive herbaceous and woody vegetation
- 7. Mastication, removal, or treatment of stumps and other woody debris
- 8. Mowing vegetation adjacent to trails and throughout the project area
- 9. Creation and management of snags
- 10. Establishment of desired vegetation including broadcast seeding and installation of live plants
- 11. Abatement of any and all damage to existing parking areas, roads, and trails adversely impacted as a result of project implementation
- 12. Coordination, planning, permitting, preparation, and implementation of ecological burns
- 13. Documentation of site conditions before, during, and following project implementation
- 14. Provision of information to the community re: the project purpose, project schedules project outcomes. Friends will utilize social media and newsletters, on-site signage, brochures, project tours, and local media (print, radio, and television outlets)
- 15. Accounting for project expenses and preparation of required reports
- Proposed Levy The Board of County Commissioner's voted on August 19, 2022 to approve Parks' levy to be placed on the November ballot. Henry presented the explanatory statement

that will be in the voter's pamphlet along with additional levy information. Henry stated Parks Director, Dan Hurley, included in the board order a list of proposed special projects.

#### 00:47:06 Old Business

- PAC Vacancy At large vacancy posted on July 21, 2022, no applications have been received yet.
- Vice Chair Vacancy Greg Hyde was nominated vice chair for rest of fiscal year, Kevin Shanley motioned, Mike Allen seconded, motion passed unanimously.

- Fern Ridge Water Capacity Parks received 4.3M in funds from the American Recovery Plan Act dedicated to water and sewer restoration and improvements at Armitage, Richardson, Orchard Point, and Baker Bay. The request for proposal (RFP) will be going out soon.
- Forest Glen Landing FEMA will provide partial funding to rebuild vault restroom. Restroom will be rebuilt, be double-walled, and also relocated so it is entirely on County property. More parking will also be added with the funding coming from an Oregon State Marine Board (OSMB) grant Parks was awarded. The boat ramps will also be redesigned. Project will take about three to four years from permitting to completion.
- HBRA Waterway Access Parks received an Oregon State Marine Board (OSMB) grant to work on improving waterway access at the coast fork of the Willamette River. Permits should be in place around June, 2023.
- Eagle Rock Parks will be receiving assistance through a technical assistance Grant awarded by the National Park Service RTC. Parks will conduct public outreach prior to the planning and design phase.
- Armitage Campground Expansion Branch Engineering is helping with design and permitting. Currently looking at the sewer system and options on expanding it.
- Climate Advisory Committee Report Mike Allen gave an update of the Climate Advisory
  Committee. Allen reported phase 3 of the Lane County Climate Action Plan has been released.
  It's called the Community Climate Resilience Plan. Currently committee meetings are on hold
  due to multiple vacancies.
