Shall City of Eugene impose a 3% tax on retail sales of recreational marijuana? 14

If voters in the City of Eugene approve, this ordinance will impose a tax on the retail sale of recreational marijuana. "Recreational marijuana" or "marijuana item" means marijuana and cannabinoid products, including marijuana edibles, extracts, and concentrates, as those terms are defined in state law. The tax will not apply to medical marijuana. 53

The tax will be 3 percent of the retail sale price of the recreational marijuana. The retail seller will collect the tax when the marijuana product is sold to the consumer and will pay the tax proceeds to the City. The proceeds of the tax will be used to pay for general government services. 97

If approved by the voters, the tax will take effect on January 1, 2017. 111
