Merger Lane County Fire District #1 and Lane Rural Fire/Rescue

Shall Lane County Fire District #1 merge with Lane Rural Fire/Rescue to provide fire protection service to both districts?

**Summary** 175 words which concisely and impartially summarizes the measure and its major effect.

If adopted by the voters, Lane County Fire District #1 (LCFD) would be annexed and absorbed by Lane Rural Fire/Rescue (LRFR). LRFR, as the surviving district, would continue to provide fire protection in all areas currently served by either LCFD or LRFR. In addition, LRFR would become the owner of all funds, property, contracts, records, revenue, uncollected taxes, assessments and charges of both Districts. In addition, LRFR would become liable for both Districts' obligations, including bonded indebtedness. This merger would not affect LRFR's ability or obligation to provide ambulance service within its designated ambulance services area. Fire protection service within the affected districts is currently provided by LCFD and LRFR through an intergovernmental agreement. Pursuant to the agreement, the two districts currently operate as Lane Fire Authority. If this merger is approved by the voters, LRFR's tax rate would become \$2.0383. This merger must be approved by the voters in each district to be effective.
