WHEREAS, Lane Manual Chapter 20 sets forth policy regarding the competitive award of contracts and policy regarding signatory authority of the County Administrator; and

WHEREAS, competitive selection processes necessary for contracting with local service providers for services beginning July 1, 2017 have been completed; and

NOW, THEREFORE, the Board of County Commissioners of Lane County **ORDERS** as follows:

2. Authority is delegated to the County Administrator to sign contracts listed in Appendix A – Contract Award Recommendations for a period of two years with an option to renew for an additional two years.
