**WHEREAS**, Committee recruitment resulted in the receipt and consideration of one new and of three deferred, at-large, applications from September, 2017, for the vacant position; and


**WHEREAS**, the Public Health Advisory Committee has considered the applications received and recommends Victoria Hemphill to the Board of Commissioners for appointment;
