

Title:	Short Mountain Training Site
Contractor or other party's legal name:	City of Eugene and City of Springfield
New Contract or Amendment:	New "Restated" IGA
New Contract Amount or Amendment Amount:	\$150,000.00
Expense or Revenue:	None, IGA
Brief Description of Contract:	This shared agreement provides the sharing responsibilities for the joint use and management of the Short Mountain Public Safety Training Facilities.
Term (New or Revised):	July 1, 1018 - June 30, 2028
Previous Board Orders, if any:	99-5-26-10, 10-04-07-1
Policy Issues:	The Board of Commissioners must approve any contract in excess of \$100,000 and/or 3 years in length.
Board Goals:	This agreement allows law enforcement agencies to continue and enhance government partnerships. In addition, all partners are able to enrich their public safety skills at a managed and secured site that is away from the public.
Health Implications:	The Sheriff's Office is committed on continous basis to provide public safety training to all law enforcement agencies. Such training will enhance emergency response to life safety events.

Brief Description of Contract:	This grant reimburses for eligible costs and activities pertaining to the Lane County Hazard Mitigation Plan Update utilizing FEMA funds.
Term:	09/18/2014 - 04/04/2019
Previous Board Orders, if any:	No board order was required for the original agreement since it was under the 3 years and/or \$100,000. This amendment has no funding involved, but does extend the contract over the allotted 3 years.
Policy Issues:	The Board of Commissioners must approve any contract in excess of \$100,000 and/or 3 years in length.
Board Goals:	Safe, Healthy County, Vibrant Communities, and Our People & Partnerships. This funding focuses on building a mitigation plan for collaboration during a catastrophic event to protect and enhance the safety and health of Lane County residents.
Health Implications:	Planning and stratigizing for catastrophic events will enable the preventative safety and health of Lane County residents.
