I. MOTION

To Delegate Authority To The County Administrator To Sign An Expense Contract With Catholic Community Services In The Amount Of \$124,783 for the Period From May 1, 2006 through April 30, 2007.

II. <u>DISCUSSION</u>

A. Background / Analysis

LC Human Services Commission received a U.S. Housing & Urban Development grant for providing shelter for homeless Latino males. The grant funded a Latino shelter program managed by Centro LatinoAmericano for two years. The original contract ended January 31, 2006. The agency was forced to close the shelter on January 3, 2006 with very short notice to the community. Meanwhile HUD approved a renewal grant for the same service for the period beginning February 1, 2006.

The loss of the provider's ability to providing temporary shelter combined with the possibility of not utilizing federal funding created an emergency response from homeless providers. The providers along with HSC Staff formed a committee to create a substitute program. The first goal of the committee was to attempt to identify an organization with a shelter facility and the staff to provide the services as written into the original design. Upon further analysis, it became clear that the facility did not exist and there was an increasing need for rental assistance for homeless Latino families as well as single homeless Latino men living in the metropolitan area of Eugene and Springfield.

As a result, the Human Services Commission requested a program change from HUD to allow a project to provide scattered-site rental assistance for Latino households. HUD approved the request. Upon approval, providers were approached about completing the HUD contract year to provide the new service. Catholic Community Services agreed to "pilot" the project. HUD amended the original contract to extend the ending date from January 31, 2007 to April 30, 2007. The extension enabled the committee more time to create a project design which included outcome strategies to address homelessness amongst the Latino community.

A Notice of Intent (NOI) was published to inform the community of the intent to procure services as a backfill to the original program design. No other organization responded to the notice. If HUD continues to fund the program, a bidding process will be completed during March of 2007.

A contract with Catholic Community Services was written. However, in the process of completing the preparations for changing the program from Centro LatinoAmericano, a change to the delegated authority was required. The purpose for this board item is to request delegated authority to sign the expense contract with Catholic Community Services.

B. Recommendation

Approve the Delegation of Authority to the County Administrator to sign the expense contract with Catholic Community Services for Latino Housing in the amount of \$124,783 for the period from May 1, 2006 through April 30, 2007.
