I. MOTION

MOVE TO ENTER INTO A PERPETUAL INTERGOVERNMENTAL AGREEMENT WITH THE CITY OF EUGENE TO PROVIDE FOR THE OCCASIONAL RENTAL OF VEHICLES.

II. ISSUE OR PROBLEM

Shall Lane County approve entering into an Intergovernmental Agreement with the City of Eugene to provide for the occasional rental of vehicles?

III. BACKGROUND/IMPLICATIONS OF ACTION

A. Board Action and Other History

Lane County has historically entered into Intergovernmental Agreements to provide for the occasional rental of vehicles with local municipalities. The City of Eugene has the occasional need for additional vehicles, and Lane County occasionally has surplus vehicles awaiting disposal at public auction. Such relationships have been beneficial for both parties by providing cost efficient and convenient vehicle rental to local municipalities while lowering County charges to internal customers through sharing costs with a larger customer base.

Lane County has provided vehicle rental services to various municipal agencies since 1989. The contracts between the County and these agencies have worked well for all parties.

B. Policy Issues

C. Board Goals

Lane County and various public agencies have established a policy of mutual cooperation on projects of mutual benefit and of benefit to the public at large. Entering into this agreement with the City of Eugene will result in providing lower cost direct and indirect services to the citizens of Lane County, and will further the economic good of the citizens and industries of our community as defined in Section B3.a.2 of the Strategic Plan.

D. Financial and/or Resource Considerations

Revenue from this agreement is expected to generate less than \$5,000.00 annually. The City of Eugene will provided liability and physical damage insurance on all rented vehicles, which will cover the operational cost of the vehicles. Lane County will provide all maintenance and repairs.

E. Analysis

Current Intergovernmental Agreements with Housing Authority and Community Services Agency, Lane Council of Governments, Lane Educational Service District and Willamalane Parks & Recreation District have served the County well for many years. Entering into this agreement with the City of Eugene will result in lowering County charges to internal customers through sharing costs with a larger customer base.

F. Alternatives/Options

- 1. Approve entering into an Intergovernmental Agreement with the City of Eugene. Fleet Services has been aggressive in finding new methods to lower costs and has, as part of its strategy, sought out opportunities to enter into cooperative agreements.
- 2. Do not approve entering into an Intergovernmental Agreement with the City of Eugene.

IV. Timing/Implementation

Upon approval of the Board, the Intergovernmental Agreement will be forwarded to the County Administrator for execution.

V. Recommendation

It is recommended that the Board approve entering into an Intergovernmental Agreement with the City of Eugene and that the County Administrator be delegated the authority to execute the agreement.
