II. <u>DISCUSSION</u>

A. <u>Background / Analysis</u>

This agenda item meets the abbreviated consent calendar criteria because it is approving an agreement and delegating contract signature authority to the County Administrator for contracts funded by grants or State programs.

Board Order 06-07-19-04 authorized the County Administrator to sign agreements funded through the Human Services Commission. Order 06-07-19-04 listed a series of contracts for Looking Glass: Case Management Outreach (Safe & Sound) in the amount of \$155,255, Case Management/Transitional Services for Homeless Youth (Safe & Sound) in the amount of \$53,189 and Safe Home for Youth (Safe & Sound) in the amount of \$24,036. These three service components are being combined, with additional funding in the amount of \$33,194, into a single contract in the amount of \$265,674 for case management,

substance abuse, sexual assault, mental health and street outreach services for homeless, runaway or at-risk youth through the New Roads program.

The services provided through the New Roads program at Looking Glass are part of a comprehensive program for runaway, homeless, and at-risk youth. Combining the program components allows Looking Glass to create a program plan and budget that reflect the comprehensive services being provided. This also allows Lane County to review, through quarterly reports and performance measures, the program as a whole. Letters of Interest were solicited for all components of the combined agreement. Looking Glass was the sole respondent to the request for Letters of Interest.

B. Recommendation

Lane County Health & Human Services recommends approval of the contract with Looking Glass for services through the New Roads program. Funding has been allocated through the budget process for these services and competitive selection was done for the services being contracted.
