Dear Commissioner Green,

On behalf of FOOD for Lane County (FFLC) and the GrassRoots Garden, I want to thank you, Commissioner Morrison, and the County Administration Office staff for volunteering at the Garden on Thursday, September 28. It was a wonderful *Day of Caring*, and your efforts and energy with the Ridgeline Montessori School were a marvel throughout the morning. Working together, you succeeded in permanently solving a chronic problem at the Garden – the profusion of weeds, especially bindweed that clogged the Garden entrance and made it an eyesore. We've tried to keep this area attractive as one way of thanking the church for its generous sponsorship of the Garden, but the effort has always required time and energy that could be better spent growing food.

I also want to convey our enormous appreciation for the Board of Commissioners' financial support of the Garden in past years through the Adopt-a-Plot Program, and to request continued support. The Board's adoption of our Big Boy Greenhouse through generous gifts of \$1,000 each in 2003 and 2004 was a tremendous help. FFLC and all of us in the GrassRoots Garden community are very grateful. Big Boy continues to be a center of Garden activity; used for creating seedling starts on potting tables in the early spring, and growing vegetables on the ground beds the remainder of the year. Big Boy also houses the carrot harvest festivities in December, one of the highlights of our season.

Following up on your conversation last Thursday with Master Gardener Volunteer Lynn Negus, I would like to formally request that the Board of Commissioners continue its sponsorship of the Big Boy Greenhouse. The last remittance we received from the Board for sponsorship of the greenhouse was \$1,000 on November 4, 2004. We would be delighted if the Board could sponsor the Big Boy Greenhouse again this year, and make its sponsorship continuous from 2004 by donating a total of \$2,000.
