

## DEDICATION OF A PUBLIC ROAD EASEMENT

## James F. Gillette

**GRANTOR**, grants and dedicates to LANE COUNTY, a political subdivision of the State of Oregon (GRANTEE) a public road easement on and over the following described property:

A parcel of land lying in the Northwest one-quarter (NW 1/4) of Section 14, Township 18 South, Range 4 West of the Willamette Meridian, and being a portion of the tract of land conveyed to James F. Gillette, by that certain Warranty Deed, recorded on Reel Number 1783R, Reception Number 9246047, Lane County, Oregon, Deed Records, said parcel being more particularly described as follows:

Beginning at a point being South 89°49'East 879.78 feet, North 37°27'30"East 26.30 feet and North 31°52'30"East 48.60 feet from the one-quarter corner between sections 14 and 15, Township 18 South, Range 4 West, Willamette Meridian, said point being on the southeasterly margin of County Road 846 (Lorane Highway) 30.00 feet distant southeasterly from, when measured at right angles to, the centerline thereof; thence South 41°24'30" East 10.44 feet to the southeasterly corner of that area dedicated to Lane County, Oregon in the Dedication of Public Road Easement recorded March 28, 1969, Recorder's Reception No. 58567 on a line 40.00 feet distant southeasterly from, when measured at right angles to, the centerline of said County Road; thence, North 31°52'30"East 96.18 feet along the easterly line of said Dedication last above referenced to its intersection with the north line of that tract described as Parcel 1 in that deed recorded August 17, 1992, Instrument 9246047; thence, North 36°56'20"West 42.90 feet along the westerly extension of said Parcel 1 as found monumented on the ground to a point on the centerline of County Road No. 846; thence, South 31°52'30" West 99.67 feet along said centerline to a point on the westerly projection of the south line of said Parcel 1; thence South 41°24'30"East 31.32 feet to the point of beginning in Lane County, Oregon.

The bearings used herein are based upon a Partition Plat for Marty Campbell and James F. Gillette to be filed as a survey in the Office of the Lane County Surveyor.

It being the intent herein to acquire right-of-way for Lorane Highway (County Road Number 846) which, with this dedication, will result in a right-of-way width of 40 feet from centerline as said road abuts the GRANTOR'S property.

There is no consideration for this dedication.

Said parcel being forever dedicated to the use of the public for road purposes and granting a public road easement.
