Lane County Emerald Options is a permanent housing project that provides long-term, community based housing and supportive services for homeless households with disabilities. People with developmental disabilities are particularly vulnerable to homelessness because they often have limited or no income beyond SSI and have multiple barriers to maintaining housing because they don't always fit into existing services. They need help to determine their needs and plan support services to meet those needs. Helping to build their whole lives, personally and in the community, is essential to gain competencies and independence. Lane County Emerald Options provides developmentally disabled individuals and families with case management and additional levels of community support to acquire new skills that results in stable, permanent housing. Emerald Options consists of clustered site apartments totaling 6 units and 9 scattered site units. The project coordinates with Lane County Developmental Disabilities, St. Vincent de Paul, University of Oregon Early Childhood Easy Cares, and Centro Latino Americano. Emerald Options serves 10 households with adults only and 5 households with children at any given point in time (PIT).
