Lane County uses Wellsky Community Services for the Homeless Management Information System (HMIS). LC HMIS currently has 30 partner agencies with over 290 end-users collecting and entering data for over 230 projects. LC HMIS provides the foundation for community-wide initiatives including Built for Zero, Ending Veteran Homelessness, Coordinated Entry, Frequent User System Engagement (FUSE), Dovetail, and Housing First capital investment. LC provides HMIS licenses to all end users, system administration for all partners, data analytics, and training & technical support. LC HMIS supports projects funded with Federal funding partner grants (HUD, RHY, PATH, and VA) as well as projects funded with State and local funds. Lane County has 100% local participation in HMIS for all homeless project types. HMIS is widely used throughout Lane County with demographic and service data entered for over 178,000 unduplicated individuals since 2011. One-third of the projects in HMIS are CoC Projects (SO, ES, TH, RRH, PSH). The other non-CoC projects include homeless access centers, community service centers for basic needs, overnight parking and camping projects, food pantries, and other supportive service only projects which are not directly tied to housing outcomes, but are essential components in addressing crisis needs in homeless and highly vulnerable populations. During the pandemic, many of the COVID Rent Assistance Projects have entered their data into the HMIS.

Lane County HMIS team works closely with the LC Health & Human Services' Quality & Compliance Division on a shared data warehouse. This partnership provides the foundation for analyzing the impact of the services ranging from housing to behavioral health to primary care - all of which are dependent on one another for a participant's successful outcomes. This partnership also provides the HMIS with Tableau visualization tools, which are used for project management and to inform the Poverty and Homelessness Board (CoC Board) and the public about homelessness in Lane County. HMIS provides the data used in system modeling and analysis, longitudinal studies, ongoing equity and disparity analysis, and system and project-level effectiveness.

Last year, LC HMIS launched a ticketing software and knowledge base platform. The knowledge base is easy to access and allows agency staff to search for information about data entry and reporting for their project types. It also allows providers to submit requests for technical assistance. The efficiency of this system allows HMIS staff to respond to requests more quickly, improve existing training materials, and provide more specialized support.
