WHEREAS, certain changes to Lane Manual Chapter 64 are desired to bring the applicable jurisdictional amounts for the Lane County Justice Courts in line with Oregon law (LM 64.215 Civil Jurisdiction and LM 64.220 Small Claims).

NOW, THEREFORE, IT IS HEREBY ORDERED, Lane Manual Chapter 64 is amended by removing, substituting and adding the following sections:



64.215 Civil Jurisdiction.

Civil jurisdiction extends generally to those cases not excluded by state law and where the amount of money, damages or specific property claimed does not exceed the value provided by Oregon State statutes, ORS Chapter 51. If the state law is silent as to jurisdictional amount, then the claimed value may not exceed \$10,000. *(Revised by Order 99-9-1-2; Effective 9.1.99; 03-1-15-5, 1.15.03)*

64.220 Small Claims.

The Small Claims Department has jurisdiction for the recovery of money or damages where the amount claimed does not exceed the value provided by Oregon State statutes, ORS Chapter 46, and if the state law is silent as to jurisdictional amount, then the claimed value may not exceed \$10,000. The Small Claims Department has sole jurisdiction where the amount claimed does not exceed \$750. *(Revised by Order 99-9-1-2; Effective 9.1.99; 03-1-15-5, 1.15.03)*

64.215 Civil Jurisdiction.

64.220 Small Claims.

The Small Claims Department has jurisdiction for the recovery of money or damages where the amount claimed does not exceed \$5,000 ~~and has sole jurisdiction where the amount claimed does not exceed \$200.~~ **the value provided by Oregon State statutes, ORS Chapter 46, and if the state law is silent as to jurisdictional amount, then the claimed value may not exceed \$10,000. The Small Claims Department has sole jurisdiction where the amount claimed does not exceed \$750.** *(Revised by Order 99-9-1-2; Effective 9.1.99; 03-1-15-5, 1.15.03)*
