ORDER NO: 12-12-11-08

**IN THE MATTER OF TRANSFERRING
LANE COUNTY PAROLE AND
PROBATION SERVICES FROM THE
DEPARTMENT OF PUBLIC SAFETY
TO THE OFFICE OF COUNTY
ADMINISTRATION; AND
VALIDATING PAST PRACTICE**

WHEREAS, by Order 08-3-12-8 (hereafter "Order") the Lane County Board of Commissioners, with the agreement of then-Sheriff Russ Burger, transferred Lane County Parole and Probation Services from the Department of Health and Human Services to the Department of Public Safety; and

WHEREAS, the Order specified that the transfer of the function of providing parole and probation services would last only so long as the term of the existing Sheriff (Russ Burger) and that the function of providing parole and probation services would automatically return to the authority of the Lane County Board of Commissioners at the end of Sheriff Burger's term of office; and


WHEREAS, the existing term of office to which Sheriff Burger was elected will conclude upon the confirmation of the term of office of Sheriff-elect Tom Turner on January 7, 2013; and

WHEREAS, Sheriff Turner was appointed to fill the vacant office of Sheriff which occurred upon the resignation of Sheriff Burger and therefore Sheriff Turner succeeded to, and assumed the Office of Sheriff subject to, the prior concurrence of Sheriff Burger with respect to the transfer of parole and probation services effected by the Order for the balance of the term to which Sheriff Burger was elected; and

WHEREAS, upon taking office as the duly elected Sheriff of Lane County, Sheriff Turner, pursuant to the Order's terms and the Lane County Charter, is not required to concur with the continued transfer of parole and probation services to the Department of Public Safety; and

ORDERED, that staff is given direction to implement these changes in a reasonable manner with the goal of accomplishing the complete transfer of Parole and Probation Services to the Office of County Administration on or before March 31, 2013; provided however that budgeting and collective bargaining responsibilities are immediately upon adoption of this Order transferred to the Office of County Administration or the County Administrator's designee.

I concur with the transfer of the Lane County Department of Parole and Probation from the Department of Public Safety to the Office of County Administration upon the terms and conditions set forth above.


